## **Description of architectural elements**

Architectural Element	Description
Configuration	Defines a set of capabilities that must develop the SME to establish the minimum requirements to enable it to implement the model of maturity level of R&D, to manage your knowledge.
Formative	It defines a set of capabilities that specify the mechanisms to be implemented in SMEs so that knowledge of R & D tacit about services, products, processes and people is accessible to all members of the SME; on the other hand it defines the capabilities that must develop an SME for the formation of its members be enriched with knowledge itself generated within the SME.
Operative	It aims to provide SMEs with the necessary capabilities to enable its members to access the knowledge of R & D explicit to reuse in their daily activities and to enrich it with new experiences, additional resources or examples of use
Proactive	It defines a set of capabilities that allow members of the SME make use of knowledge proactively, allowing them to know at all times the use and the opinion of those knowledge assets of R & D that have contributed to that based on this information, a person is able to decide how to manage their stored contributions, enriching what are most useful, delete, or completely remake themselves are not providing value to SMEs.
Assessment SP3	It helps satisfy the need for SMEs to know the benefits and advantages that entails making the effort to represent their knowledge of R & D explicitly; to achieve this, this architectural element proposes a set of capabilities that allow monitoring of the use of knowledge assets R&D.
Social	It helps provide SMEs with the necessary skills to manage the way in which its members interact to create knowledge assets R & D, and reuse knowledge explicitly represented in the execution of their daily tasks, not only at staff, but

	also at the level of working groups or functional areas of an SME.
Transactional memory	It defines a set of capabilities that enable an SME to define a repository of knowledge of R & D organization that allows storing the knowledge about the know-how that members of the organization have on services, processes and products; for the development of the daily activities of its members; there also stored knowledge, evolve while used and reused.
